BE IT REMEMBERED that on this day came on to be heard the above captioned and numbered cause; and the Plaintiff and the Defendant appeared before the Court; whereupon, Defendant agreeing hereby that Plaintiff should have and recover judgment herein, and the Court considered the pleadings on file in this cause, being of the opinion that Plaintiff is entitled to judgment from and against the said Defendant in the sum and amount of \$12,656.43, together with interest upon such indebtedness at the rate of 6% per annum from April 9, 2005 until paid, reasonable attorneys' fees in the amount of \$4,218.81, for all costs of Court in this behalf expended, and interest on said attorneys' fees and costs of court from the date of entry of this judgment at the rate of 8.25% per annum until paid; it is therefore,

It is further Ordered that Plaintiff shall have all such writs and orders that shall become in Plaintiff's behalf necessary to enforce the execution hereof. This judgment finally disposes of all parties and claims and is appealable. All relief not expressly granted herein is denied.
